One to five registered voters may complete a box by printing their name and address and signing in the space provided.

All signers on a petition must be a **registered voter** in the county designated on the petition.

Part 2 In the box "DECLARATION OF PERSON CIRCULATING SECTION OF RECALL PETITION" you must fill in all shaded areas in your own handwriting. Follow the instructions carefully to avoid rejection of the petition.

-Only registered voters of California may sign and circulate petitions.

-You may circulate as many petitions as you wish, however, you can only sign the petition for recall once.

-You can circulate petitions in more than one County, but all signers of each petition must be from the **same** county. Start a new petition for each County

-A petition is valid even with **one** signature.

PETITION FOR RECALL

TO THE HONORABLE California Secretary of State.

Pursuant to the California Constitution and California election laws, we the undersigned registered and qualified electors of the State of California, respectfully state that we seek the recall and removal of Gray Davis holding the office of Governor, in California.

We demand an election of a successor to that office. Governor of California.

The following Notice of Intention to Circulate Recall Petition was served on 2/5/2003 to Gray Davis:

NOTICE OF INTENTION TO CIRCULATE RECALL PETITION. TO THE HONORABLE GRAY DAVIS:

Pursuant to Section 11020, California Election Code, the undersigned registered qualified voters of the State of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from the office of Governor of the State of California, and to demand election of a successor in that office. The grounds for the recall are as follows: Gross mismanagement of California Finances by overspending taxpayers' money, threatening public safety by cutting funds to local governments, failing to account for the exorbitant cost of the energy fiasco, and failing in general to deal with the state's major problems until they get to the crisis stage. California should not have to be known as the state with poor schools, traffic jams, outrageous utility bills, and huge debts....all caused by gross mismanagement.

The answer of the officer sought to be recalled is as follows: IF YOU SIGN THIS PETITION, IT MAY LEAD TO A SPECIAL ELECTION THIS SUMMER COSTING US TAXPAYERS AN ADDITIONAL \$20-40 MILLION. Last November, almost 8,000,000 Californians went to the polls. They voted to elect Governor Davis to another term. Just days after the Governor's inauguration in January, however, a handful of rightwing politicians are attempting to overturn the voters' decision. They couldn't beat him fair and square, so now they're trying another trick to remove him from office. This effort is being led by the former Chairman of the State Republican Party, who was censured by his own party. We should not waste scarce taxpayers' dollars on sour grapes. The time for partisanship and campaigning is past. It's time for both parties to work together on our State's problems. Moreover, the allegations leveled against the Governor are false. As Governor, Davis has vetoed almost \$9 BILLION in spending. California, along with 37 other states, is facing a budget deficit due to the bad national economy. The Bush Administration has announced the federal deficit this year will be the biggest in history, \$304 BILLION.
